# A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD OF COMMISSIONERS TO DESIGNATE LEGISLATIVE DISTRICT BOUNDARIES

WHEREAS, Henry County, Tennessee elects numerous office holders on a district basis, according to districts into which the county is subdivided; and

WHEREAS, The Tennessee and Federal Constitutions require that these legislative districts be reapportioned and re-designated every ten years so as to reflect changes in population and for the purpose of ensuring that all such districts are roughly equivalent in population; and

WHEREAS, The Board of Commissioners of Henry County,
Tennessee deems it appropriate to designate legislative districts within the
county.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Henry County, Tennessee, meeting in regular session on this 16<sup>th</sup> day of April, 2012, a majority or more of the membership concurring, that:

- 1. For purposes of elections to the County Commission, Henry County School Board, Henry County Road Board, Constable, and any other offices which are elected on a district basis, the Board of Commissioners does designate that the county is divided into five legislative districts, intending that they be of roughly equivalent population.
- 2. The districts, according to the map attached, are legal boundaries of each district and are as designated on the attachment to this resolution, which is herein incorporated by reference.

**BE IT FINALLY RESOLVED** that a true copy of this Resolution be spread upon the Commission record of this date.



# A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD OF COMMISSIONERS TO ADOPT A PLAN OF SETTING THE SPEED LIMIT ON A COUNTY ROAD LISTED ON THE OFFICIAL ROAD LIST OF HENRY COUNTY, TENNESSEE

WHEREAS, Tennessee Code Annotated, §55-8-153(d), provides that a county legislative body has the authority to prescribe such lower speed limits as it may deem appropriate on any road being maintained by such county and shall erect appropriate signs and traffic signals; and

WHEREAS, the Henry County Highway Commission, at their regularly scheduled meeting held on Monday, March 12, 2012, voted to request the speed limit on a certain county road be lowered and posted accordingly; and

**WHEREAS,** the Henry County Legislative Body is desirous of acting favorably on said recommendation;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of County Commissioners of Henry County, Tennessee, assembled in regular session this 16<sup>th</sup> day of April, 2012, that:

Section 1. The speed limit on the county road listed below shall be set as follows: Forsythe Road - 25 mph

**Section 2.** The Henry County Highway Department is hereby directed to erect suitable speed limit signs at appropriate locations on the above-stated road.

**Section 3.** The provisions of this Resolution shall become effective upon its passage, the public welfare requiring it.
