RESOLUTION NO. 10-5-11

A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD OF COMMISSIONERS TO APPROVE A MUTUAL AID ASSISTANCE AGREEMENT BETWEEN THE BORDER COUNTIES OF HENRY COUNTY, TENNESSEE AND CALLOWAY COUNTY, KENTUCKY

For Disasters and Other Related Emergencies

WHEREAS, the safety of the citizens of Henry County, Tennessee and Calloway County, Kentucky is of the utmost importance to all levels of state and local government; and

WHEREAS, Henry County, Tennessee and Calloway County, Kentucky are aware that in the event of a major emergency incident whether caused by man or nature within the region of Northwest Tennessee and Southwest Kentucky, all the resources of local government and the private sector may be needed to meet the needs of citizens; and

WHEREAS, Henry County, Tennessee and Calloway County, Kentucky seek to enter into a Mutual Aid Assistance Agreement in order to provide for the sharing of resources, personnel and equipment in the event of a local disaster or emergency incident; and

WHEREAS, the State of Tennessee, the Commonwealth of Kentucky, and the Federal Emergency Management Agency (FEMA) have recognized the importance of the concept of written mutual aid agreements between all levels of government to facilitate emergency assistance and reimbursement; and

WHEREAS, pursuant to the Constitutions of the State of Tennessee and the Commonwealth of Kentucky, counties are allowed to enter into mutual aid and assistance agreements which may include provisions for the furnishing and exchanging of supplies, equipment, facilities, personnel and services during a natural or man-made disaster and/or other emergency incident; now

THEREFORE, the parties agree as follows:

SECTION I

DEFINITIONS

- A. "Agreement" shall mean this document, the "County to County Mutual Aid Agreement for Disasters and Other Emergencies."
- B. "Aid and Assistance" shall include, but not be limited to, personnel, equipment, facilities, services, supplies, and other resources.
- C. "Authorized Representative" shall mean an official of a party to this Agreement who has been authorized in writing by that party pursuant to the terms of this Agreement, to request, offer, or provide assistance under the terms of this Agreement.
- D. "Disaster or other emergency incident" shall mean the occurrence or imminent threat of widespread or severe damage, injury, loss of life or property resulting from an intentional, accidental or unintended release of

- any substance in or material in any form or quantity which poses an unreasonable risk to the safety and health and to the property when released, natural incidents, explosions, fires, collapses or any other incident or event which directly affects public safety.
- E. "Provider" means a party to this Agreement that has received a request to furnish aid and assistance to the party in need ("Recipient").
- F. "Recipient" means a party to this Agreement receiving aid and assistance from another party.

Section II.

OBLIGATIONS OF THE PARTIES

Provision of Aid and Assistance – Pursuant to the terms and conditions set forth in this Agreement, the parties hereto shall provide each other with aid and assistance in the event of a local disaster or emergency. Assistance includes local emergency response agency personnel, public works personnel, equipment, facilities, services, supplies, aid, and other resources, which are requested by Recipient from Provider.

- A. It is mutually understood that each party's foremost responsibility is to its own citizens. This Agreement shall not be construed to impose an absolute obligation on any party to this Agreement to provide aid and assistance pursuant to a request from another party. Accordingly, when aid and assistance have been requested, a party may deem itself unavailable to respond and shall so inform the party setting forth the request.
- B. Procedures for Requesting Assistance Requests for assistance shall be made by the Authorized Representative of a party to the Authorized Representative of the other party. Such request must indicate that it is made pursuant to this Agreement. Such request may be made by telephone or radio, to be followed as soon as practicable by a written confirmation of that request. Requests should be as specific as possible as to the type of assistance needed (e.g., number of trained law enforcement/fire fighter personnel, number and type of fire apparatus needed, number of EMS ALS units needed, generator wattage, etc. FEMA Typing guidelines should be utilized.) Requests should also indicate the length of service expected and where personnel should report for staging, and any obstacles personnel might encounter enroute to assignment.
- C. Minimum Training to be deployed- Each party will insure personnel being deployed to requesting party will credentialed to have met minimum training certifications in responders respective field that is recognized for like service in the providers jurisdiction. This will insure a basic level of service and competence in the requesting jurisdiction by provider's employees.
- D. Designation of Authorized Representative Each party to this Agreement shall designate an Authorized Representative. Such designation shall be communicated, in writing, to the Chief Executive Officer of the other party upon the execution of this Agreement. Such designation may be amended at any time by the Chief Executive Officer (CEO) of a party upon notice.

- a. Henry County authorized representatives- County Mayor (CEO), County Sheriff, or County Emergency Management Director.
- b. Calloway County authorized representatives- County Judge Executive (CEO), County Sheriff, or County Emergency Management Director.
- E. Traveling Employees Unless otherwise specified by Recipient or agreed by the parties in writing, it is mutually understood that Recipient will provide for the needs of the Provider's traveling employees. Recipient shall pay for all reasonable out-of-pocket costs and expenses of Provider's personnel, including, without limitation, transportation expenses for travel to and from the disaster area, food and if necessary, lodging. If Recipient cannot provide such food and/or lodging at or near the disaster area, the Recipient shall so advise the Provider, and shall specify in its request for assistance that only personnel who can provide for their own needs are requested.
- F. Supervision and Control Each party will agree to utilize the National Incident Management Systems ("NIMS") during all emergency incidents or events requiring mutual aid assistance. The Provider shall designate supervisory personnel amongst its employees sent to render aid and assistance to the Recipient. Recipient shall provide necessary credentials to the Provider's personnel authorizing them to operate on behalf of the Recipient. Recipient shall assign work tasks to Provider's supervisory personnel, and unless specifically instructed otherwise, Recipient shall have the responsibility for coordination between Provider's supervisory personnel and Recipient. Based upon such assignments set forth by Recipient, Provider's supervisory personnel shall have the authority to:
 - a. Assign work and establish work schedules for Provider's personnel;
 - b. Maintain daily personnel time records, material records, and a log of equipment hours;
 - c. Report work progress to Recipient at regular intervals as specified by Recipient.
- G. Period of Service; Renewability; Recall Unless agreed otherwise, the duration of the Provider's assistance shall be for an initial period of twenty-four (24) hours, starting from the time of arrival. Thereafter, assistance may be extended in increments agreed upon by the Authorized Representatives of Provider and Recipient. Provider's personnel, equipment and other resources shall remain subject to recall by Provider to provide for its own citizens if circumstances so warrant. Provider shall make a good faith effort to provide at least 8 hours advance notification to Recipient of Provider's intent to terminate such assistance, unless such notice is not practicable, in which case as much notice as is reasonable under the circumstances shall be provided.

SECTION III.

REIMBURSEMENT

A. Except as otherwise provided below, it is understood that Recipient shall reimburse Provider for the following documented costs and expenses incurred by Provider as a result of extending aid and assistance to

Recipient. Under a Presidential Disaster Declaration, FEMA will provide reimbursement of emergency work which is described as mutual aid work provided in the performance of emergency work necessary to meet immediate threats to life, public safety, and improved property, including firefighting activities.

- 1. Personnel During the period of assistance, Provider shall continue to pay its employees according to its then prevailing ordinances, rules, regulations and agreements.
- 2. Equipment Provider shall be reimbursed by Recipient for the use of its equipment during the period of assistance according to established FEMA equipment rates.
- 3. Material and Supplies Provider shall be reimbursed for all materials and supplies furnished by it, used, or damaged during the period of assistance. The Recipient shall not be responsible for reimbursing Provider for the costs of any damage caused by gross negligence, willful and wanton misconduct, intentional misuse, or recklessness of Provider's personnel. Provider's personnel shall use reasonable care at all times in the use and control of all materials and supplies used by them during the period of assistance. The measure for reimbursement for materials and supplies shall be determined in accordance with FEMA and local county reimbursement policies. In the alternative, the parties may agree in writing that Recipient will replace the materials and supplies used or damaged, with materials and supplies of like kind and quality.
- B. Record Keeping Recipient shall provide information, directions, and assistance for record keeping to Provider's personnel; Provider shall maintain records and invoices for reimbursement.
- C. Billing and Payment Provider shall send an invoice for reimbursable costs and expenses, together with appropriate documentation as required by Recipient, as soon as practicable after said costs and expenses are incurred, but not later than forty-five (45) days following the period of assistance. Recipient shall pay the bill, or advise of any disputed items, not later than forty-five (45) days following the billing date.
- D. Inspection of Records Provider agrees that it shall make its records regarding costs and expenses for assistance provided under this Agreement available for audit and inspection upon request by the Recipient, State of Tennessee, Commonwealth of Kentucky, and the federal government, and shall maintain such records for at least seven (7) years after the date of final payment under this Agreement.

SECTION IV.

PROVIDER'S EMPLOYEES

Employee is defined as a person providing emergency response services or support services who is under the exclusive direction or control of a party or local emergency response agency, whether the person is compensated for those services (e.g. wages) or is employed in a volunteer capacity.

- A. Rights and Privileges Whenever Provider's employees are rendering aid and assistance pursuant to this Agreement, such employees shall remain the responsibility of the Provider and retain the same powers, duties, immunities, and privileges they would ordinarily possess if performing their duties within the geographic limits of the Provider.
- B. Workers' Compensation Recipient shall not be responsible for reimbursing any amounts paid or due as benefits to Provider's employees due to personal injury or death occurring during the periods of time such employees are engaged in the rendering of aid and assistance under this Agreement. It is mutually understood that Recipient and Provider shall be responsible for payment of such workers' compensation benefits only to their own respective employees.

SECTION V.

NONDISCRIMINATION

In accordance with Federal Title VI laws and all other applicable local, State and Federal constitutional, statutory and administrative nondiscrimination provisions, the parties to this Agreement shall not discriminate against any employee or applicant for employment on account of race, creed, color, sex, national origin, disability, or marital status.

SECTION VI.

HOLD HARMLESS

To the extent permitted by law, each party (as Indemnitor) agrees to protect, defend, indemnify, and hold the other party (as Indemnitee), and its offices, employees and agents, free and harmless from and against any and all losses, penalties, damages, assessments, costs, charges, professional fees, and other expenses or liabilities of every kind and nature arising out of or relating to any and all claims, liens, demands, obligations, actions, proceedings, or causes of action of every kind in connection with or arising out of Indemnitor's negligence, acts, errors and/or omissions. To the extent that immunity does not apply, each party shall bear the risk of its own actions, as it does with its day-to-day operations, and determine for itself what kinds of insurance, and in what amounts, it should carry. Each party understands and agrees that any insurance protection obtained shall in no way limit the responsibility to indemnify, keep, and save harmless the other parties to this Agreement.

SECTION VII.

AMENDMENTS

This Agreement may be modified at any time upon the mutual written consent of the parties. Additional municipalities may become parties to this Agreement upon the acceptance and execution of this Agreement.

SECTION VIII.

DURATION OF AGREEMENT

SECTION 1. A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD OF COMMISSIONERS TO APPROVE AN INTERLOCAL AGREEMENT WITH THE CITY OF PARIS, TENNESSEE AND THE HENRY COUNTY MEDICAL CENTERINTER LOCAL AGREEMENT

WHEREAS, the City of Paris, "City" and the County of Henry, "County" have been negotiating with Henry County Medical Center, "HCMC" and Bethel University, "Bethel", for construction of a joint building project between HCMC and Bethel, "Project"; and

WHEREAS, the City has entered into a Memorandum of Understanding with HCMC and Bethel, a copy of which is attached to this Interlocal Agreement; and

WHEREAS, the City has entered into a Contract of Purchase and Sale with The White Oak Family Partnership, L.P., "White Oak" to purchase real estate for construction of the proposed Project; and

WHEREAS, the City intends to borrow from the Tennessee Municipal League Bond Pool, "Bond Pool", an amount not to exceed \$6,500,000.00 for construction of the Bethel portion of the Project; and

WHEREAS, The City and Bethel will enter into a Lease Purchase Agreement wherein the lease amount will be equal to or greater than the sum necessary to service the City loan debt to the Bond Pool, together with any other City expenses incident to this Project.

NOW, THEREFORE, the City and County Agree as follows:

- 1. This Project shall be considered a joint venture between the City and County.
- 2. In the event of default by HCMC and/or Bethel in the construction of this Project, the City shall request the County accept an ownership interest in the property purchased by the City from White Oak as set out more fully herein below.

- 3. In the event of default by Bethel of payments under the Lease Purchase Agreement, the City shall request the County be responsible for payment of ½ of the outstanding debt owed the Bond Pool by Bethel for the construction of this Project.
- 4. In the event of default by Bethel as set out hereinabove, and in exchange for the County's assumption of ½ of the outstanding debt owed, the City shall convey an ownership interest in the Project to the County in a proportion equal to the debt obligation the County assumes and pays.

IN WITNESS WHEREOF, the City Commission and County Commission have approved this Agreement as evidenced by signature of the City Mayor and County Mayor on day and date below written.
